#### **FUNDED CHILDCARE**

There are 3 types of government funded childcare available to parents;

- > <u>ALL</u> 3 and 4-year-olds are eligible for 15 hours from the term after they turn 3.(*Universal Entitlement*)
- SOME 2-year-olds are eligible for 15 hours from the term after they turn
   (\*Government Support- for low income families, those in receipt of benefits or children with additional needs, in care of LA)
- SOME9+ month olds 2-year-olds are eligible for 30 hours from the term after they turn 9 months old. (Working Families - Expanded)
- SOME 3 and 4-year-olds are eligible for an additional 15 hours (30 total) from the term after their birthday. (Working Families Extended)

#### Funded Session 'ADDITIONAL FEE' Charge;

Funded childcare hours are paid by the government to enable parents to access free high quality childcare but it is not intended to cover the cost of meals, snacks, other consumables and additional services, therefore parents are expected to pay for these.

We charge an 'ADDITIONAL FEE' per <u>funded session</u> to cover our costs of providing these during your child's funded sessions.

\* Does not apply to 15hrs 2-year-old 'Government Support' Fully Funded sessions.
